The Coal Pricing Report is sent via email around 3:45 pm CPT each day with the exception of holidays. The Weekly Recap is sent out on Monday mornings around 9:00 am CPT.

It also includes a weekly OTC coal market recap report summarizing the prior week's OTC trades, price movement, and bullet points on notable market news. **Special data request** regarding historical pricing and/or other relevant data for clients is available for those clients having a minimum of three years subscription history with Coaldesk.
